# CLINTON VALLEY ELEMENTARY PTO MEETING <br> Wednesday January $15^{\text {th }}, 2020$ Meeting Minutes 

Presidents Welcome: Kristen Murray introduced as PTO president and welcomes parents, teachers/staff to the meeting.

Principals Report: Mrs. Wright will be discussing happenings around the school. Restorative practices have been going very well. Statistics show that when using restorative practices, less children get suspended, in trouble, etc. We are getting a new playground!!! NWEA Scores have gone up! Based on F18 to F19, they have gone up.

Title One Report: It is unclear at this time if Lynn Henshaw will be present. Scholastic News (PEN dept gets that for K-4). PEN dept has a website on the district website under "For Parents"

Teacher's Report: A teacher will be reporting any needs the teachers may have. Mrs. Strohm said there was nothing to report at this time.

Treasurer's Report: Debbie Spring will discuss all transactions that have cleared this month. Currently, our account balance is $\$ 4,181.08$. $\$ 490.90$ came in from Box Tops. $\$ 638.45$ from Santa Shop. Zap Zone is next Friday, January $24^{\text {th }}$ from 6-9pm. Need to check the budget and vote on it.

## Old Business:

- Santa Shop:
- -This year's secret shop was a big success. However, upon further review and comments/concerns from parents I believe it is important to address/possibly change how Santa Shop is run for the 20202021 school year.
- The total amount of items sold was $\$ 3,397.81$. The total cost of the products came to $\$ 3,188.60$. We had a bonus for early sign up for last year (\$219.89) and total tax due was 190.68. We also had $\$ 50.00$ in bonus bucks and $\$ 180.00$ was paid via Pay Thank you (online payment option. Our total profit for this event was $\$ 638.45$. Without bonuses we would have not made much more than we made during the 2018 Santa Shop.
- Upon talking to other parents, it was suggested that the PTO purchase our own products from various sources (dollar tree, Debby's Dollar, christmascloseouts.com etc.) and run our own Santa's Shop next year. Voted unanimously to keep Fun Services for next year.
- -With pricing we used this year we made 10-15\% mark up on most of the items sold, with $15 \%$ being the highest mark up. If we were to purchase our own products and add a mark-up of 50-100\% could possibly be in the better interest of the PTO. We would also be able to determine price and keep everything under $\$ 5.00$ in hopes more students would be able to shop.
- -We sold approx. 1,344 products. We would be looking to have a budget between $\$ 1500-\$ 2000$ for the next Santa Shop.


## New Business:

Cardinal Corner going very well. While the PTO does not fund the Cardinal Corner, we help find volunteers for them. Currently we have volunteers through end of February.
